Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amount as stated above, which shall be valid for 30 days beyond the validity period of the bid, counted from the bid opening date. If bidder wishes to submit the Cash Security, the cash should be deposited in the name of Chaubise Rural Municipality, Rajarani, Dhankuta in Dharauti Account No: 0700000841 at Nepal Bangladesh Bank, Rajarani, Dhankuta and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
